1. Ownership of the domain www.cyex.es

In accordance with the provisions of Law 34/2002 on Information Society and Electronic Commerce Services, we inform you that the ownership of the domain www.cyex.es corresponds to Cyex Congresos, S.L. 2. Purpose and Scope of Application

These general conditions of use (hereinafter "conditions of use") establish the warnings, terms and conditions applicable to the use of the technical means of the website hosted under the domain name www.cyex.es that Cyex makes available to users.

Cyex may unilaterally modify, whenever it deems appropriate, the structure and design of the website, as well as modify or eliminate the services, contents and conditions of access and/or use of the website, without any obligation to forewarn or inform users of these modifications.

3. Users

Those who access and/or use this website are assigned the condition of user, and accept from that moment, fully and without reservation, these conditions of use, as well as the particular conditions which, where appropriate, supplement, modify or replace these conditions of use regarding certain services and contents of the web.

The user agrees to use the website, and its services and contents, in accordance with these conditions of use with full observance and respect for the applicable legislation and the rights of third parties, without violating current legislation, good faith, generally accepted uses and public order.
